

- The cone of silence prohibits any communications whether in writing or verbally regarding a specific procurement between:
 - A potential proposer (which includes vendors, service providers, bidders, lobbyists and consultants) and their representative(s) and <u>RIAC staff or RIAC consultants</u> engaged to assist RIAC on a specific procurement except for communications with RIAC's procurement agent or other supporting procurement staff responsible for administering the procurement, provided the communication is strictly limited to procedural matters of the Competitive Selection Process
 - A potential proposer and their representative(s) and a <u>RIAC Board member</u>
 - A potential proposer and their representative(s) and <u>any member of the selection</u> committee or negotiation team
- Further, Proposer(s) shall not offer any gratuities, favors or anything of monetary value to any RIAC employee or Board member in connection with any competitive procurement

Any violation of the cone of silence by a Proposer and their representative(s) will render voidable their response as well as any resulting contract awarded to them





Capital investment to focus on "curb appeal" to create "sense of place"

- Minimum of \$450 per square foot
- Total renovation is <u>not</u> required
- Concepts should incorporate "open architecture", where capable
- Sense of place by referencing elements of:
 - the unique architectural signature of the historic Newport mansions
 - the blend of Victorian and industrial character of Providence
 - connection to the State's nature and natural scenery
- RIAC expects that this be accomplished in a subtle and non-"Disneyesque" manner
- The construction period = no later than six (6) months after the space is made available based on Occupancy Availability Schedule for each Assigned Premise





Compensation methodology and term

Years 1 and 2:

- 1. Rent based on the Percentage Fees, plus;
- 2. Additional rent for office/storage spaces

Starting in Year 3:

- Pay monthly the greater of:
 - 1. A monthly pro-rated Minimum Annual Guarantee (MAG) or;
 - 2. Percentage Fees of the Concessionaire's monthly gross revenue
- Plus, additional rent for any office/storage spaces.
- Beginning in Year 3, a MAG = 85% of the total Year 2 Percentage Fee Rent payments
- The MAG for each subsequent year = 85% of the total prior year's Percentage Fee Rent payments to RIAC (no reduction throughout term)
- <u>Term</u>: minimum of five (5) years and maximum of ten (10) years

Food and Non- Alcoholic Beverages	12% of Annual Gross Revenue
Alcoholic Beverages	15% of Annual Gross Revenue
Lottery	25% of Annual Gross Revenue

Additional components of the procurement

- Badging: employees shall be badged according to RIAC's policy located at https://www.flyri.com/riac/badging/
- Employees: strongly encouraged to consider hiring qualified personnel previously employed by the current and previous airport concessionaires

Employee Parking:


- All employees working at the airport, and who must be badged, are permitted to purchase a parking card
- The current employee parking rate is \$35 per month and allows employees to park in Economy Parking Lot (Lot E)
- A free 24/7/365 shuttle is available from Lot E to the Terminal

Deliveries:

- All deliveries are made to RIAC's loading dock located on Delivery Drive off of Airport Road
- The Concessionaire's badged employees will receive the merchandise, perform self-inspection and transport the products to the terminal along designated routes
- Proposal Deposit: \$5,000 refundable upon completion of procurement process
- **Performance Guarantee:** equal to two (2) months' rent based on the square footage of the location multiplied by then-in-effect Signatory Airline Rate (FY23 is \$98.38 sq./ft. per year)

RIAC welcomes and encourages DBE participation

- Federal Aviation Administration (FAA) requires that Airports comply with Airport Concessions Disadvantage Business Enterprise (ACDBE) Program
- RIAC uses the Minority Business Enterprise Compliance Office for RIAC's ACDBE Certification process
- The Minority Business Enterprise Compliance Office maintains a directory identifying all firms eligible to participate as ACDBE's and updates the directory at least annually
- The goal for this contract is 2.55%
- RIAC is requiring Proposers to make a good faith effort, as defined in Appendix A, 49 CFR Part 26, to document efforts to identify potential ACDBE's

Options for ACDBE Compliance

1. 100% ACDBE Participation

The Proposer is solely owned and operated as a certified ACDBE firm in the State of Rhode Island

2. <u>Direct Ownership Percentage Participation</u>

• A percentage of the business is designated to be owned, operated and/or maintained by a certified ACDBE through a joint venture, partnership, sub-lease, management, licensee, operating and/or franchise agreement

3. Percentage of Purchases and/or Leases of Goods/Services Participation

- A percentage of the gross revenue that will be committed to the purchase of goods and services from ACDBE certified vendors
- A directory of ACDBE's certified to provide goods and services may be obtained from the Minority Business Enterprise Compliance Office

4. Demonstration of Good Faith Efforts

- Proposers must make good faith efforts to meet the goal
- A Proposer may do so either by obtaining enough ACDBE participation to meet the goal or by documenting that it made sufficient good faith efforts to do so
- Examples of good faith efforts are found in Appendix A to 49 CFR Part 26 located in the U.S. Government Publishing
 Office website Electronic Code of Federal Regulations (http://www.ecfr.gov/)


